This paper is not well organized, for example it does not explained related research as basic of the research performed. Some paragraphs seem to be missing, causing incomplete explanation of research procedure and prompt its procedure continuity.

Too many formulas and table without sufficient explanation. The paper must be rewritten to describe the proposed simulation, the optimization problem, the method used, and the simulation result in more detailed.

The title: "Utility Function Based-Mixed..." or "Utility Function-Based Mixed..." ?

The new idea of the proposed pricing scheme should be explicitly defined in abstract and the method used.

The simulation objective and scenarios must be described.

The optimization problem in the form of equation must be explained.

The solution tables (XIII, XIV, XV) must be explained in more detail.

The recapitulation tables (XVI, XVII) must be explained in more detail. Some of the table cells must be merged (data and type of pricing column).

There are some language and readability issue. Please proofread the paper.
