The following are an explanation for respond to the referee's comments.

**Materials and method section:**

1. Since 2012 IDHS using a complex sampling design which stratified sampling (stratified three-stage design), so weighted is needed. The weighted is done in order to sample variance equal to variance in population, the aim to equate probability chosen as samples in each strata (*equal probability of selection method*), so the conclusion of this study can be generalized to population.
2. Weights calculated using a sample weight (V005), we divide it by 1000000 before applying the weighting factor (V005/1000000). In SPSS, fill in strata field with *region* (V024), in clusters field with *primary sampling unit* (V021), and in sample weight field with V005/1000000
3. Population are women aged 15-49 years in NTB province. Based on 2012 Indonesia Health Profile, there are 1,316,378 women of childbearing age in NTB, aged 15-49 year. However, we did not write this amount because the study population same with the population 2012 IDHS, there are 1,368 women.

**Result section**

1. The wealth index is a composite measure of a household's cumulative living standard. The wealth index is calculated using easy-to-collect data on a household's ownership of selected assets, such as televisions and bicycles; materials used for housing construction; and types of water access and sanitation facilities.  
The wealth index is presented in the DHS Final Reports and survey data sets. Generated with a statistical procedure known as principal components analysis. DHS separates all households into five wealth quintiles: 1) Poorest (score < 20%), 2) Poorer (score 20%-39%), 3) Middle (score 40%-59%), 4) Richer (score 60%-79%), 5) Richest (score  $\geq$  80%).  
  
Visited by FP/health workers were defined if women was visited by a Family Planning or health worker in the twelve months preceding the interview (none/either/both).
2. This is only a variables have significant that shown in fix model in logistic regression model

3. Only reference categories of each variable in this table.  
in example : unmet need among women with parity of 2-3 children (reference categories) is 0.735 times higher than women with parity without 2-3 children
