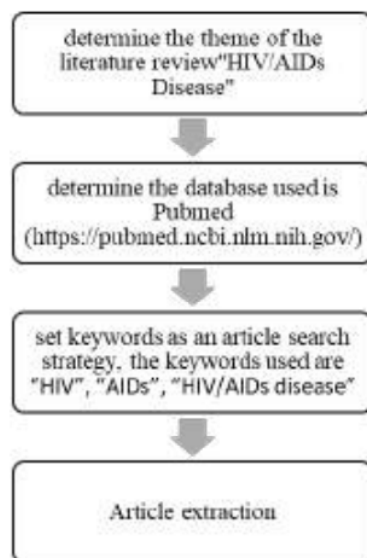


Figure 1: Literature Review Work Procedure
