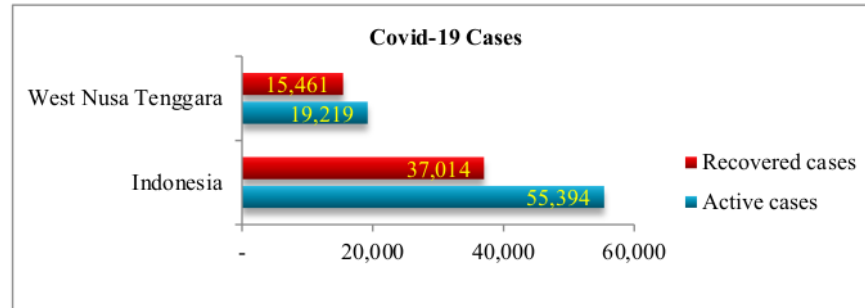


Figure 1. People affected by Covid-19

With the availability of health nurses, of course, managing the spread of the virus can be overcome. To reduce the number of coronaviruses spreads more widely, the critical role of health workers is needed by all people in improving the quality of health.
