

The paper titled, "Functional Characteristic Improvement of Edible Film Through Addition of Gambier and Bay Leaf Extract", by Santoso et al. reports Edible film poses antioxidant characteristic which is classified as strong category with thickness that fulfill JIS 1975 standard. The hypothesis of the current study is not new and the result is predictable. I regret to advice against this paper for the following reasons:

- 1) The manuscript is not written well, and it lacks originality, since procedure used for studies were already published and no additional modification is done.
- 2) In Materials and methods session:
 - how the film obtained was characterized not explained and how mechanical properties were measured
 - Information on antioxidant studies not provided (how it was performed)
 - Information on antibacterial methods not provided (how it was performed)
- 3) A separate session for statistics should be included in "Materials and Methods".
- 4) Error bar should be included in graph.
- 5) Results and discussion are poor. Conclusion should be more elaborate.
- 6) Check for typographical and grammatical errors. Many parts of the text are difficult to read.

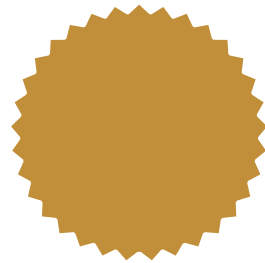
