ABSTRACT

Sriwijaya University Learning Management System is a learning platform carried out online through a particular portal or application. Sriwijaya University has facilitated learning activities between students and lecturers online through the E-Learning portal of Sriwijaya University. This study tried to find out the students' perceptions toward online learning using UNSRI E-Learning. The population of the study was two hundred ninety-seven (297), from the population, samples were taken using purposive sampling, with a sample of two hundred twenty-three (223) students in English education study program from three different semesters were chosen as the sample. The data were collected using the questionnaire. The questionnaire was given to the students online and recorded their responses in the Google form with 15 items and a four-point Likert-scale questionnaire ranging from (1) strongly disagree to (4) strongly agree, a quantitative descriptive approach was used. The data were analyzed using SPSS 25.0 and Ms. Excel to process the questionnaire responses. The results showed that the second, fourth and sixth semester students had similar perceptions. The responses of the questionnaire from all the participants showed that most of the students had good perceptions on online reading learning through UNSRI E-Learning with percentage of 63.68% (142 students).



1.1 Background of the Study

When growing up, the teaching and learning process grows with various dimensions and the teaching and learning process becomes formal and systematic, along with technology that

Online learning which started in 1970 has various terms to express opinions or ideas, namely: on-line learning, internet-enabled learning, virtual learning or web-based learning. It can be concluded that online learning is a process of instruction or learning using electronic tools to help deliver, develop, evaluate and facilitate the teaching and learning process in which students are central and can be done anytime and anywhere. According to (Onno W. Purbo, 2005) the internet is a medium that allows a communication process to take place efficiently by connecting it with various applications.

Coronavirus pandemic has affected many human activities including the education system around the world, which has led to the closure of almost total

schools, universities and colleges, including Sriwijaya University, since mid-March 2020 approximately 1,723 billion students have been affected due to school closures, due to Education is something that is very important and a form of long-term investment that every human being has. So, in response to the pandemic in response to school closings, the University recommends the use of distance learning programs and open education applications and platforms that schools and teachers can use to reach learners remotely and limit educational disruptions.

Educational institutions are running abnormally because of the corona pandemic, the impact of this corona pandemic spread throughout the world which resulted in education in Indonesia also being affected, namely experiencing a lockdown and the closure of educational institutions that have not been determined for how long, face-to-face learning is stopped to prevent the spread of corona so that the system learning must be replaced with online learning methods or learning from home. In this online learning system, student perceptions can be used as evaluation material to improve the quality of learning.

Online learning has six main principles, namely: a) Learning is open, b) Learning is social, c) Learning is personal, d) Learning is augmented, e) Learning is multi represented, f) Learning is mobile. This, of course, requires online learning tools or media that can fulfill these six aspects. Online learning can be used for all courses in the higher education reading system, which in this case is for reading learning in the English study program.

Sriwijaya University learning management system or E-Learning UNSRI is a learning activity that is carried out online through a particular portal or application. Sriwijaya University has facilitated learning activities between students and lecturers online through the E-Learning portal of Sriwijaya University (Asdin & Erlina, 2022). E-Learning is defined as distance learning that uses computer technology or usually called the internet Allan J. Henderson (2003). Learning activities involving lecturers and students either directly face-to-face or indirectly (online) require students (students) to register in the learning system. According to Waller (2001), ELearning is a learning process effectively

generated by how to combine delivery digitally material consisting of support and services in learning.

Along with speaking, listening, and writing, reading is one of the four language skills taught in the English language learning process. Snow claimed that reading is necessary for success in contemporary society and that, of all the abilities, it is the most important one. Reading comprehension is highly regarded and critical for academic and social progress. Furthermore, reading enables access to essential knowledge for use at work and in school, according to Komiyama (2013), and fosters the development of general competency. Reading is useful not only in the field of education but also in social and professional settings, so it can be said that daily living and reading activities are closely intertwined. One of the most crucial components of learning, especially in learning, is reading. Reading is one of the important things in learning, especially in learning English, with a lot of reading will improve fluency and accuracy in speaking English and understanding the contents of the reading. on the other hand, learning to read encourages wise language use and the information is meant to help students understand how English works.

Students respond favorably to the use of online learning platforms like Edmodo or Quipper, according to a study conducted by Laxmi Mustika Cakrawati in 2017. The research indicates that students' perceptions of the use of online learning platforms in ELF classrooms are between 65 and 75 percent agree and strongly agree with the statement that the use of online learning. The students who took part in the study see these platforms as user-friendly learning tools that encourage them to interact with their teachers and peers outside of the classroom. regarding the current situation, the writer will collect data on FKIP UNSRI students how students' perceptions of online learning using Sriwijaya university learning management system whether online learning has achieved the target of good teaching and learning quality.
